PROBLEM GAMBLING AND SPECIAL POPULATIONS: ADOLESCENTS, WOMEN, CRIMINAL JUSTICE

BRIEF PROGRAM/COURSE DESCRIPTION

The Kentucky Council on Problem Gambling's 13th Annual Educational and Awareness Conference, sponsored by the Kentucky Division of Behavioral Health, will examine problem gambling's impact on special populations, including adolescents, women and criminal justice. The conference assembles qualified presenters in these areas to discuss the extent and trends of the impact of problem gambling on individuals and society. They will offer insights and suggestions on proven and emerging treatment practices. Identified as a behavioral control disorder by the American Psychiatric Association, problem and pathological gambling affects almost 60,000 Kentuckians according to 2008 survey data commissioned by the Kentucky Council on Problem Gambling.

The program detailed on the following pages consists of 10.25 hours of CEU-approved classroom lecture and panel presentations augmented by audio-visual aids and participant discussion.

WHO SHOULD ATTEND

The Kentucky Council on Problem Gambling 13th Annual Educational and Awareness Conference is an appropriate learning opportunity for:

- any alcohol or substance abuse counselor, social worker, psychologist, psychiatrist, marriage and family therapist or clergy;
anyone in a recognized mental health, behavioral health, medical or school counseling discipline;
anyone in the legal profession or involved in criminal justice; or
human resource or employee assistance professionals.

All will benefit from knowledge of the impact pathological gambling may have on individuals or family, at the workplace or in legal matters.

MEASURABLE LEARNING OBJECTIVES

Participants will increase basic understanding of problem and pathological gambling and increase their skill sets by exposure to proven education, awareness, prevention and treatment techniques. Qualified professionals will be the presenters. A post-program participant evaluation will be used to measure whether the Kentucky Council on Problem Gambling's 13th Annual Educational and Awareness Conference achieved its goals.

PRESENTERS

Jeffrey L. Derevensky, Ph.D. is Professor of School/Applied Child Psychology, McGill University, Montreal, Canada, and Co-director, International Centre for Youth Gambling. He presents internationally on youth gambling issues and impacts.

RonSonLyn Clark, Psy.D., CCGC, is Director, Substance Abuse Services, River Valley Behavioral Health, Owensboro, Ky. She is the first female certified gambler counselor practicing in the Commonwealth of Kentucky.

Rick Benson, CCGC, CPGC, NCGC-II, is Director, ALGAMUS Recovery Centers, which provides residential treatment of pathological gamblers.

Kath Gilliam, MPS, is Vice President Operations, Helen Palmer, Inc., which has pioneered the use of enneagram in gambling treatment.

Steve Burton, MSW, LCSW, NCGC-I, is Director, Problem Gamblers Help Network of West Virginia, and CEO of First Choice Systems, Inc., which operates the Charleston, WV-based helpline services.

Deneen L. Hernandez, MS, is Supervisory Forensic Examiner, Cryptanalysis and Racketeering Unit, Federal Bureau of Investigation. Part of her duties is investigation of evidence in criminal activity related to gambling.
